ADOPT RESOLUTION 2016-12

The following Resolution 2016-12 was proposed by Trustee Banker who moved its adoption and seconded by Trustee Sidari:

WHEREAS; the Village of Albion and the citizens it serves recognize the value to the community of improving municipal parkland for public use, including Bullard Park; and

WHEREAS; the goal of the Albion Recreation Committee, established in 2011, is to see the limited and valuable green space of Albion preserved, maintained, and enhanced for current and future generations; and

WHEREAS; the Albion Recreation Committee is comprised of numerous community member volunteers that meet approximately 12 times annually and continuously solicit community input and support, establish fundraising opportunities and promote awareness of park resources; and

WHEREAS; although Bullard Park contains a number of features for community use, many of them are in need of improvements, including baseball fields, basketball courts, lighting fixtures, skate parks, and landscaping that have been identified by the community, Albion Recreation Committee and the Village of Albion to acknowledge Bullard Park as a priority area to be addressed due to use, increasing deterioration, and safety issues; and

NOW, THEREFORE, be it RESOLVED that the Village of Albion fully approves and endorses the Albion Recreation Committee and the Rebuild Bullard Park Project and affirms public and community support for each;

Further, it is RESOLVED that Dean London, as Mayor of the Village of Albion, is hereby authorized and directed to accept funds from the New York State Office of Parks, Recreation and Historic Preservation in accordance with the provisions of Title 9 of the Environmental Protection Act of 1993, in an amount not to exceed \$500,000, and enter into and execute a project agreement with the State for such financial assistance to the Village of Albion for the Rebuild Bullard Park Project and, if appropriate, a conservation easement or preservation covenant or public access covenant to the deed of the assisted property.
